### **Acceptable Use Policy**

#### **To the Parents:**

It is very important that you read this document and discuss the content with your child. There are several areas where you need to *indicate your option* and *sign the document*.

If you sign the document but neglect to indicate your option, it will be assumed that you are agreeing to the conditions set forth.

*Your choices will stay in effect throughout your child's high school years.* If conditions change, you must notify the office in writing. For example, if you agree to let your child's picture appear in the newspaper or on the Internet but then decide that you no longer want to allow this, you must notify the school as soon as possible.

#### **To the Students:**

You must read this document and understand the conditions under which you are entitled to use the technology provided in school—the network, classroom computers, etc. You should understand that your technology privileges could be terminated if you fail to comply with these conditions.



## **North Arlington High School and Computer/Internet Acceptable Use Policy**

The North Arlington School District provides the use of computer facilities and Internet access for **educational use only**.

The term, "Computer Facilities", is defined to include computers and their peripherals, computer networks, connections to external computer networks, and Internet access.

"Licensed Software" refers to copyrighted programs, data and documentation.

**Educational use** is defined to include classroom activities, career development, and limited high-quality, self-discovery activities. Access to the Internet has not been established as a public access or public forum. Access to the Internet is available through this school only with permission of the principal or his or her designee and your parents.

The North Arlington school system has the following rights:

1. to place reasonable restrictions on the material you access or post
2. to determine the training you need to have before you are allowed to use the system
3. to enforce all rules set forth in the school code and the laws of the state of New Jersey

Students are responsible for good behavior on school computer networks just as they are in a classroom or a school hallway. General school rules for behavior and communications apply. Network storage areas may be treated like school lockers. Network administrators may review files and communications to maintain system integrity and insure that users are using the system responsibly. Users should not expect that files stored on district servers will always be private.

The following activities involving the use of computer facilities are unacceptable:

### **Personal Safety and Privacy**

- Posting contact information (address, phone number, etc.) about yourself or any other person;
- Agreeing to meet with someone you have met online without approval of your parents;
- Posting a message that was sent to you privately without the permission of the person who sent you the message.

### **Use of External Devices**

- Unauthorized access to a computer, the Network, or the Internet via external devices such as cell phones, MP3 players, iPods, or flash drives. Any use of a flash drive should be monitored by a teacher.

### **Inappropriate Access to Material**

- Accessing material that is profane or obscene (pornography) or that advocates illegal acts or violence or discrimination toward other people (hate literature).

## **Inappropriate Language**

- Using or transmitting material containing obscene, profane, lewd, vulgar, rude, inflammatory, threatening, or disrespectful language. You will not post information that could cause danger or disruption or engage in personal attacks or harassment of another.

## **Illegal and Inappropriate Activities**

- Internet game playing, portal hunting to gain access to My Space and/or Facebook or any other “personal-post” site, blogging, instant messaging, etc. is considered to be inappropriate activities during school time.
- Attempting to gain unauthorized access to this or any other computer system or go beyond your authorized access by entering another person's account number or accessing another person's files;
- Attempting to deliberately disrupt the computer system or destroy data by spreading computer viruses or by any other means;
- Engaging in any other illegal act, such as arranging for a drug sale or the purchase of alcohol, engaging in criminal gang activity, threatening the safety of a person, etc.
- Initiating or forwarding “chain” e-mails, which tax network resources and slow its performance.

## **Plagiarism and Copyright Infringement**

- You will not plagiarize words that you find on the Internet. Plagiarism is taking the ideas or writings of others and representing them as if they were your own.
- You will respect the rights of copyright owners. Copyright infringement occurs when you inappropriately reproduce a work that is protected by copyright. If a work contains language that specifies appropriate use of that work, you should follow the expressed requirements. If you are unsure whether or not you can use a work, you should request permission from the copyright owner.

## **System Security**

- Harming or destroying data or equipment;
- Making unauthorized copies of software;
- You are responsible for your individual files and should take all reasonable precautions to prevent others from being able to use your account. Under no circumstances should you give your password to another person.
- You will immediately notify a teacher if you have identified a possible security problem. Do not look for security problems; this may be construed as an illegal attempt to gain access.

Violations of this Computer/Internet Acceptable Use Policy will cause immediate suspension of your computer facilities and Internet privileges and may result in further disciplinary actions being taken by North Arlington High School, the North Arlington Board of Education, the State of New Jersey, or Federal authorities. Such activities may also result in forfeiting access to elective technology courses for the remainder of the student's high school experience.

**Parental/Guardian Consent Form**
